- 註:
1. 如電磁爐某表列型號的單一樣本的測試結果符合以下標準(產品能源標籤實務守則2023(守則)第 14.9 段),則該表列型號會獲接納為符合有關規定:
 - (a) 所測試出的每個加熱單元及整個電磁爐所得的功率輸入,不得少於每個加熱單元及整個電磁爐額定功率輸入的 95%,或高於每個加熱單元及整個電磁爐額定功率輸入的 105%。
 - (b) 所測試中所計算出的熱效率,相等於指明人士根據在第 14.4.5 段所訂明相關級別的熱效率規定而釐定的熱效率或較該熱效率為佳。
 - (c) 就第 1 至第 4 級的評級而言,測試所得的備用模式功率消耗量不得超過 1 瓦(如只有一個加熱單元),或不得超過 2 瓦(如有兩個或以上加熱單元)。
 2. 表列的數值經四捨五入方式顯示。
 3. 該型號在首次測試未能符合要求後,在進一步的測試中所得的測試結果。
 4. 根據《能源效益(產品標籤)條例》(第598章)第17條,此產品型號的參考編號已從表列型號的紀錄冊上被刪除。因此,此產品型號不得在本港供應。

- Note:
1. A listed model of Induction Cooker will be accepted as conformance if the test results of a single sample of the listed model meet the following criteria (clause 14.9 of the Code of Practice on Energy Labelling of Products 2023 (the Code)):
 - (a) The tested power inputs of each heating unit and whole induction cooker shall be neither less than 95% nor greater than 105% of the rated power inputs of each heating unit and whole induction cooker.
 - (b) The thermal efficiency calculated in the compliance monitoring testing being equal to or better than the requirements of thermal efficiency as stipulated in Clause 14.4.5 for the respective grade determined by the specified person.
 - (c) The tested standby power consumption shall not exceed 1W for one heating unit or 2W for two or more heating units for Grade 1 to 4.
 2. All values are rounded figures.
 3. Results of further testing conducted after failure of the product to pass the first test.
 4. Under section 17 of the Energy Efficiency (Labelling of Products) Ordinance Cap. 598, the reference number of the model has been removed from the record of listed models. As a result, this model is not allowed to be supplied in Hong Kong.
