- 註: 1. 如洗衣機某表列型號的單一樣本的測試結果符合以下標準(產品能源標籤實務守則2023 第10.10段),則該表列型號會獲接納為符合有關規定:
  - (a) 所測試出的耗電量(千瓦小時/循環)不高於其額定耗電量的15%以上;
  - (b) 所測試出的耗水量(公升/循環)不高於其額定耗水量的15%以上;
  - (c) 所測試出的洗滌表現及所測試出的脫水表現符合根據產品能源標籤實務守則2023表10.3所列的有關測試標準釐定的最低規定(適用於第1至第4級的評級);及
  - (d) 所測試出的能源效益級別符合以下其中一項規定:
    - (i) 在監察測試中所計算出的能源效益級別,相等於指明人士向機電工程署呈交的測試結果所釐定的能源效益級別或較該級別為佳;或
    - (ii) 在監察測試中所計算出的能源效益級別,如不等於指明人士向機電工程署呈交的測試結果所釐定的能源效益級別或較該級別為差,則在監察測試中所計算出的特定耗電量,
      - 不得高於向機電工程署呈交的測試結果所計算出的特定耗電量的115%,並在任何情況下不得高於下一個較低能源效益級別所允許的最高特定耗電量。

- Note: 1. A listed model of washing machine will be accepted as conformance if the test results of a single sample of the listed model meet the following criteria (clause 10.10 of the Code of Practice on Energy Labelling of Products 2023):
  - (a) The tested energy consumption (kWh/cycle) being not greater than the rated energy consumption by more than 15%;
  - (b) The tested water consumption (litres/cycle) being not greater than the rated water consumption by more than 15%;
  - (c) The tested washing performance and tested water extraction performance conforming with the minimum requirements in accordance with the respective test standards as shown in Table 10.3 of the Code of Practice on Energy Labelling of Product 2023 for Grade 1 to 4.
  - (d) The tested energy efficiency grade meeting either one of the following:
    - (i) The energy efficiency grade calculated in the compliance monitoring testing being equal to or better than the energy efficiency grade determined by the test results submitted to EMSD by the specified person; or
    - (ii) If the energy efficiency grade calculated in the compliance monitoring testing being not equal to nor better than the energy efficiency grade determined by the test results submitted to EMSD, the tested specific energy consumption calculated in the compliance monitoring testing being not greater than 115% of the specific energy consumption calculated by the test results submitted to EMSD, and in any cases not greater than the highest specific energy consumption allowed in the next lower energy efficiency grade.
  - 2. All values are rounded figures.
  - 3. Under section 17 of the Energy Efficiency (Labelling of Products) Ordinance Cap. 598, the reference number of the model has been removed from the record of listed models. As a result, this model is not allowed to be supplied in Hong Kong.
