Notification of Incidents involving Builders' Lifts and Tower Working Platforms

As stipulated in sections 19(4), 20(5) and 22(6) of the Builders' Lifts and Tower Working Platforms (Safety) Ordinance, where the registered examiner is not satisfied that the builder's lift or tower working platform, as the case may be, complies with the relevant requirements set out in section 9 of the said Ordinance or is not in safe working order, he shall *immediately* report that the fact to the Director of Electrical & Mechanical Services (this office) and the registered contractor, and the registered contractor shall take the necessary steps to correct the problem. Your co-operation to strictly conform such requirements would definitely enable us to provide more effective response in handling the incident.
